Easyprint Bangkok respects intellectual property laws. Having said that, it is impossible for us to check the intellectual ownership of every image and the onus is on you when you upload an image. Please do not use other people's work without obtaining prior permission.

You uploaded images are stored on a secure server. We will hold on to them for 6 (six) weeks in case you want or need a reprint. After this period, the images will be deleted.

By placing an order, you agree to purchase the production of this product. The production of the product will not begin before the Website has received the payment for the purchase. All orders are subject to availability at the time of purchase. We will make every effort to ensure the shortest shipment time possible. Shipment times may vary and could be subject to delays in the postal services used by the Website or force majeure for which the Website cannot be held responsible.

Purchasing a product through the Website is possible without signing up for the good and services provided by the Website. However, the data provided for payments and shipment of the product will not be retained by the Website. Signing up to the Website has the advantage that Clients will be able to use the data stored when ordering another product. The client agrees that all information provided when ordering a product, be it as a one-time user or a Client who signs up to the website, when is accurate. #### **Shipment:**

Shipping of a purchased product will be carried out by a third party. There are reasonable guarantees that, certainly within Bangkok, delivery will occur one day after the product is finished. When a client has ordered a product that uses glass, special protection is needed to ensure that the product reaches the client in the condition it has left the production site in. The cost for the special protection and shipment itself will be borne by the Client.
